## FISCAL NOTE ANALYSIS

STATE OF ALASKA  
2019 LEGISLATIVE SESSION**Analysis**

In different sections, the bill reduces the earned compliance credits (ECC) for probation and parole from one-half to one-third. While statute limits officers' caseloads to 75 cases, the department believes it will be able to handle the additional length of time on probation or parole with existing resources.

The bill repeals mandatory early termination of probation and returns it to a true recommendation from the probation officer. This is likely to result in some probationers spending additional time on probation at a cost of \$9.57 per day. At this time the department projects it will be able to handle this change with existing resources.

This bill extends the maximum time on probation for a sex offense from 15 years to 25 years and for all other offenses from five years to 10 years. While these provisions will impact the department, because of the long time windows that impact will not be felt during the window of this fiscal note.

This bill necessitates that the department changes a number of aspects of regulations. This will require a Criminal Justice Planner located in Anchorage to undertake this work for two years. The cost for this position is \$127.8.
