FISCAL NOTE ANALYSIS

STATE OF ALASKA 2019 LEGISLATIVE SESSION

Analysis

This bill amends AS 18.65.670 relating to the Village Public Safety Officer (VPSO) program by including "Alaska Native organizations" as entities eligible to receive grant funds from the Department of Public Safety (DPS) to participate in and administer the VPSO program within their region, and defines "Alaska Native organization" as an organization listed under AS 47.27.070(a).
Under AS 18.65.670(b) funds are appropriated to DPS to provide grants to eligible entities for village public safety officers. Most of the organizations listed under AS 47.27.020(a) currently receive VPSO grants. Though this bill would expand the organizations eligible to participate in the VPSO program, DPS does not anticipate a fiscal impact as a direct result of its passage. Therefore, a zero fiscal note is being submitted.
VPSO Program regulations under 13 AAC 96.010 - 13 AAC 96.900 would need to be amended to make conforming changes related to entities eligible to participate in the VPSO Program as well as other necessary updates. DPS estimates the regulation process would take no longer than 18 months from the effective date of July 1, 2019, to complete. Therefore, a January 1, 2021, date has been identified as the date by which the regulations would be adopted by.
