However, in FY14, the legislature recognized the need for additional flexibility on the University's part to make internal transfers between campuses and a single appropriation was again established.</p> <p>In FY16 and FY17, programs were transferred from the Systemwide Education and Outreach (SEO) allocation to the University of Fairbanks. Effective FY18, SEO no longer exists as a separate allocation.</p> <p><b>University of Alaska Foundation</b> - Positions (25 PFT/1 PPT) and funding of \$3.9 million related to the University of Alaska Foundation were transferred out of the Statewide Services allocation in the Governor's FY19 budget request. The Foundation is a separate legal entity with a mission to seek, secure and steward philanthropic support to build excellence at the University of Alaska.</p> <p><b>Education Trust of Alaska</b> - Positions (7 PFT) and funding of approximately \$1.5 million related to the Education Trust of Alaska were also transferred out of the Statewide Services allocation in the FY19 budget. The Trust was established in 2001 by the UA Board of Regents to implement and manage the Alaska College Savings Program. Currently, the Trust offers three college savings plans necessary to bring a high quality college savings program to Alaskans.</p>

Therefore, the legislature reduced the University of Alaska receipt authority by \$36 million beginning with FY14. This action is an attempt to get the University's budget more in line with prior year actuals to allow for a more realistic and accurate representation of the overall University of Alaska budget.
