BUDGET ACTION:

The House Finance Budget Subcommittee for the Office of the Governor held one meeting with the agency. The Subcommittee reviewed the FY2015 budget request and took the following actions:

Accepted the Governor's amended proposal, which includes these highlights:

- Various expenditure reductions totaling \$561,600 UGF
- Eight positions deleted with funding of \$654,800 UGF
- Personal services rate decreases of \$80,600 (\$78,300 UGF, \$1,900 Other Funds, and \$400 Federal Funds)
- Removal of multi-year appropriations for the Redistricting Board totaling \$2,185,100 UGF
- Funding for salary increases of \$160,900 UGF
- Funding for initiative public hearings as a one-time item of \$30,000 UGF

 Added funding for statewide primary and general elections costs as a one-time item of \$3,693,800 UGF

The Subcommittee made the following adjustments:

- Changed the \$3 million funding request for the domestic violence and sexual assault initiative back to a one-time item and added intent language similar to last year's intent.
 - o It is the intent of the legislature that the Office of the Governor delivers a report on the results of the domestic violence and sexual assault initiative through December 31, 2014, along with effectiveness and efficiency performance measures that are developed with a numerator and denominator format, to the legislature by February 17, 2015.
