## House Finance Budget Subcommittee Legislature

February 28, 2014

The House Finance Budget Subcommittee for the Legislature submits an operating budget for FY2015 as follows:

#### **BUDGET ACTION:**

The House Finance Budget Subcommittee reviewed the FY2015 budget request and took the following actions:

Made the following changes to the Legislature's amended proposal that includes these UGF highlights:

- Reduced uncollectible receipt authority of \$20,000 in Administrative Services
- Denied the request of \$6,900 in the Select Committee on Ethics for personal services costs
- Denied the request of \$37,300 in the Office of Victims' Rights for case management and personnel services costs

- Denied the request of \$44,800 in the Ombudsman for personal services and contractual services cost increases
- Denied the request of \$142,200 to the State Facilities Rent allocation for state equipment fleet costs of \$20,000 and \$122,200 for rent/lease costs

The above denied items are anticipated to be absorbed within existing funding.

Added 14 PPT positions and reduced UGF by \$1,500 and DGF by \$1,000;
 and increased Other Funds by \$2,500 in Session Expenses

The Subcommittee also took the following actions:

- Reduced excess authorization of \$250,000 in Legislative Audit
- Reduced excess authorization of \$950,000 in Legislative Finance to be split evenly between the House and Senate Finance Committees
- Reduced excess authorization of \$1,300,000 in Committee Expenses

The Legislature's budget is \$2.5 million UGF below the Governor's Amended budget.
